The Ministry of Water and Environment – Water for Production Regional Centre- Central has allocated/received funds to be used for the acquisition of Construction of Kigatto-Bwetamiza Small Scale Irrigation scheme in Butambala District to increase on crop production.

- 1. The Entity invites sealed bids from eligible bidders for the provision of the above works.
- 2. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) and the Regulations made under the Act and is open to all bidders.
- 3. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8(a).
- 4. The bidding document which has been prepared in the *English language* may be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of **UGX: 100,000/=(Uganda shillings One Hundred Thousand Only)**. The method of payment will be through the bank.
- 5. Bids must be delivered to the address below at 8(c) at or before 11:00am. All bids must be accompanied by a *bid security in form of an unconditional bank guarantee* of UGX 20,880,000=(Uganda Shillings Twenty Million Eight Hundred Eighty Thousand Shillings Only). Bid securities must be valid 28 days after validity expiry. Late bids shall be rejected. Bids will be opened online at 11:30 am on date of bid submission
- 6. There shall be a pre-bid/ site visit meeting was held on 28th February, 2022 at **10:00am** with bidders assembling at **Water for Production Regional Centre Central offices. Site visit is mandatory bidders**
