Procurement Package: PROCUREMENT OF CIVIL WORKS FOR OFF-FARM IRRIGATION INFRASTRUCTURE AND FACILITIES

The Government of the Republic of Uganda has received financing from the Arab Bank for Economic Development in Africa (BADEA) toward the cost of the Farm Income Enhancement and Forestry Conservation Programme -Project-3 (FIEFOC - 3), and intends to apply part of the proceeds toward payments under the contract for *Procurement of Civil Works for Off-farm Irrigation Infrastructure and Facilities:*

- A) Lot 1 Northern and Central Upper Regions 36No.
- B) Lot 2 Western and Central Lower Regions 36No.
- C) Lot 3 Eastern Province and Karamoja Area 24No.

The Ministry of Water and Environment now invites sealed bids from eligible bidders for the construction of *Civil Works for Off-farm Irrigation Infrastructure and Facilities*.

The Scope of Works entails the provision of basic irrigation sources including construction of earth moving reservoirs to collect irrigation water through 9 lakes, 23 seasonal rivers, 41 swamps and rehabilitation of 13 reservoirs, the processing of about 10 wells and springs, pump and overhead tank with solar panels as energy source.

Further details on the above works are provided in the bidding document. The qualification requirements are detailed in Section III of the Bidding document.

Bidding will be conducted in accordance with the *National Competitive Bidding Procedures* for the Arab Bank for Economic Development in Africa's (BADEA) which is available on the Bank's website at <u>http://www.badea.org</u>. Eligible firms must be Arab or African, or Arab African Joint Venture (JV) firms. The Association/JV must submit with their bid information including details of ownership, Nationality, and the Association/JV Agreement stating the share for execution of the contract for each party.
